076/22 Proposed New Residential Development on Land at Intall Fields Farm, Stoke Prior

A member of the public spoke to the Parish Council regarding the local opposition to the now proposed development of 90 homes on this site. He referred to the questionnaire which had been sent planning consultants and it was clear that only a select number of homes had ben selected for the consultation. The proposed site was largely in a green belt area although the planning consultants were claiming that part of the site was actually brownfield land.

After discussion, the Parish Council were unanimously agreed that they were opposed to the proposed scheme to build 90 homes on this site. The Clerk was asked to contact Bromsgrove District Council to see what the current planning situation was with this site.

082/21 Audit 2021/22 (1) Internal Auditor's Report

After a brief discussion, it was agreed to note the report but to take on board the need to introduce a system of internal checks on payments.

(2) Summary of Receipts and Payments as at 31 March 2022

The Parish Council approved the summary of receipts and payments for 2021/22 and agreed that they could be signed off by the Chairman and the Clerk.

(3) Annual Return and Governance Statement

The Parish Council gave their unanimous approval to the Chairman and the Clerk being given authority to sign off the Annual Audit Return and approval was also given to the Annual Governance Statement contained therein.

083/22 20mph Speed Limits Campaign

The Clerk reported that all Parish Councils in Worcestershire were being urged to sign up and support the 20's Plenty for Worcestershire campaign which was imed at putting pressure on Worcestershire County Council to limit speed on streets and roads in the county where people live, work, shop, play or learn.

After discussion, the Parish Council agreed to support the campaign and passed the following resolution:-

That the Parish Council calls on Worcestershire County Council to implement 20mph speed limits in Stoke Prior and Stoke Heath and that the Clerk should write to the County Council to respond positively to this request.

084/22 Film Night 3 September 2022/Salt Fest 2-4 September 2022

After discussion, it was agreed that the Parish Council should not take part in this year's Salt Fest.

With regard to the Film Night, it was agreed that this should go ahead on Saturday 3 September 2022. The Chairman asked the Clerk to enquire whether Top Gun: The Maverick would be available this year. Alternatively it should be the latest James Bond film.

It was also agreed that the usual facilities including toilets, first aid and parking at Bromsgrove School should be booked.

085/22 Correspondence

The Clerk reported that the Parish Council had received the grant of £5,000 from Bromsgrove District Council towards the cost of replacing the fence and gates at Stoke Heath Recreation Area.

086/22 Councillors Points of Information and Items for Future Meetings

Paul Pittaway reported that Bromsgrove Preparatory School would be contacting the Parish Council regarding the installation of a blue plaque for John Corbett on the wall of the school building.

Liz Miller commented on the young trees which had been damaged or removed from Ryefields Road Recreation Area and asked whether it would be possible to replace them with 3 or 4 more mature specimens. Chris Cooke stated that he still had a number of the young trees which were growing and it was suggested that they be planted on the site next year when they were more robust.

Chris Cooke raised the following items:-

He had toured the parish with the County Council's new Highways Liaison Officer and a number of issues had been highlighted as needing to be dealt with:-

The idea of a footpath down Buntsford Hill should be pursued with Cty/Cllr Kyle Daisley.

HGV signage – A site meeting with Gary Williams from the County Council would be arranged.

The proposals to install double yellow lines along parts of Ryefields Road would go ahead.

The wall at Corbett Business Park was inspected and would be further reviewed by the County Council's Engineers.

Signage will be provided for Needlemill Lane.

It was agreed that the Parish Lengthsman's report would be a standing item for all future agendas.
